1. The corporate title of said company is MISSISSIPPI STATE COLLEGE ALUMNI, INCORPORATED.

2. The Names of the Incorporators are:

3. The Domicile of the Corporation is State College, Mississippi.

4. The amount of capital stock is NONE.

5. The par value of each share is NONE.

6. The period of existence (not to exceed fifty years) is FIFTY YEARS.

7. The purposes for which it is created are as follows:

~~State College; To do all things and acts for the promotion of education~~
~~and recreation at Mississippi State College, and in the State of Mississ-~~
~~ippi, to further and promote the interest of the alumni of Mississippi~~
 State College, and of the people of the State of Mississippi, in the
 education and physical development in the State of Mississippi and in
 her institutions of learning; and to solicit and secure funds, to grant
 financial scholarships and to do all things necessary and convenient
 for the carrying out of the foregoing purposes; To buy and sell property,
 both real and personal; to borrow money and give security therefor; to
 enter into contracts, and do and perform all acts necessary and convenient
 for the carrying out of the foregoing purposes., and those rights conferred
 by Chapter 4, Title 21, Code of 1942 and amendments thereto.

8. The corporation shall issue no shares of stock, shall divide no dividends or profits among their members, shall make expulsion the only remedy for non-payments of dues, shall vest in each member the right to one vote in the election of all officers, shall make the loss of membership by death or otherwise, the termination of all interest of such members in the
